If the grantee is found to have exclusion after the grant has been award, encumbrances will be place on all active awards. Stop payment will begin on any pending payment claims. Audits will begin to verify compliance of all awards. DCJS will pursue repayment of funds that were expended during the exclusion period. If the subrecipient fails to remit funds owed to DCJS, the funds will then be deemed uncollectible debt by DCJS. Uncollectible debt will be reported to the Virginia Department of Taxation Debt Set Off program, Office of the Attorney General and third-party collections. DCJS may add fees, fines and penalties to the original amount of the debt owed.

# 8. Requirement to report actual or imminent breach of personally identifiable information (PII)

## 19. Restrictions on "lobbying"

In general, as a matter of federal law, federal funds awarded by OJP may not be used by the subgrantee, either directly or indirectly, to support or oppose the enactment, repeal, modification, or adoption of any law, regulation, or policy, at any level of government. ### 22. Restrictions and certifications regarding non-disclosure agreements and related matters

#### 25. Access to grant records

#### 26. Discrimination findings

The subgrantee assures that in the event that a Federal or State court or Federal or State administrative agency makes a finding of discrimination after a due process hearing on the ground of race, religion, national origin, sex, or disability against a recipient of victim assistance formula funds under this award, the subgrantee will forward a copy of the findings to the Office for Civil Rights of OJP and DCJS.

## 27. Performance Measurement Reporting

The subgrantee agrees to submit quarterly performance reports on the performance metrics identified by DCJS and the Bureau of Justice Assistance (BJA) and in a manner required by DCJS and BJA.

## 28. Documentation requirements

The subgrantee agrees promptly to provide, upon request, financial or programmatic-related documentation related to this award, including documentation of expenditures and achievements.

### 29. Additional monitoring requirements

The subgrantee understands that it may be subject to additional financial and programmatic onsite monitoring, which may be on short notice, and agrees that it will cooperate with any such monitoring.

Subgrantees with a grant designation of "Planning" will be required to have bi-monthly meetings with DCJS RSAT monitor to review planning progress. Subgrantees will be responsible for scheduling and conducting the required meetings.

The subrecipient agrees to comply with DCJS grant monitoring guidelines, protocols, and procedures, and to cooperate with DCJS on all grant monitoring requests, including requests related to desk reviews, enhanced programmatic desk reviews, and/or site visits. The recipient agrees to provide to DCJS all documentation necessary to complete monitoring tasks, including documentation made under this award. Further, the subrecipient agrees to abide by reasonable deadlines set by DCJS for providing the requested documents.

Failure to cooperate with DCJS's grant monitoring activities may result in sanctions affecting the recipient's awards, including, but not limited to: encumbrances being placed on all active awards, referral to the Office of the State Inspector General for audit review; designation of the subrecipient as High Risk; or termination of an award(s).

#### 30. Record retention and access

Records pertinent to the award must be retained for a period of three (3) years from the date of submission of the final expenditure report. Subgrantee must provide access, including performance measurement information, in addition to the financial records, supporting documents, statistical records, and other pertinent records indicated at 2 C.F.R. 200.333.

### 31. Non-Supplanting requirement

The subgrantee agrees to submit a final financial report and return all received and unexpended grant funds to DCJS within 45 days of the end of the grant award period.

### 35. Travel Policy

Subgrantees may follow their own established travel rates if they have an established travel policy. DCJS reserves the right to determine the reasonableness of an organization's travel policy. If the subgrantee does not have an established policy, then they must adhere to federal travel policy. DCJS allows reimbursement for actual reasonable expenses and meals according to per diem. Transportation costs for air and rail must be at coach rates.

## 36. Project initiation

Within 60 days of the starting date of the grant, the subgrantee must initiate the project funded. If not, the subgrantee must report to DCJS, in writing, the steps taken to initiate the project, the reasons for the delay, and the expected starting date. If the project is not operational within 90 days of the start date, the subgrantee must obtain approval in writing from DCJS for a new implementation date or DCJS may cancel and terminate the project and redistribute the funds.

#### 37. Contract Amendments
