A **Sustainability Framework** with eight domains that can help build capacity for maintaining a program.

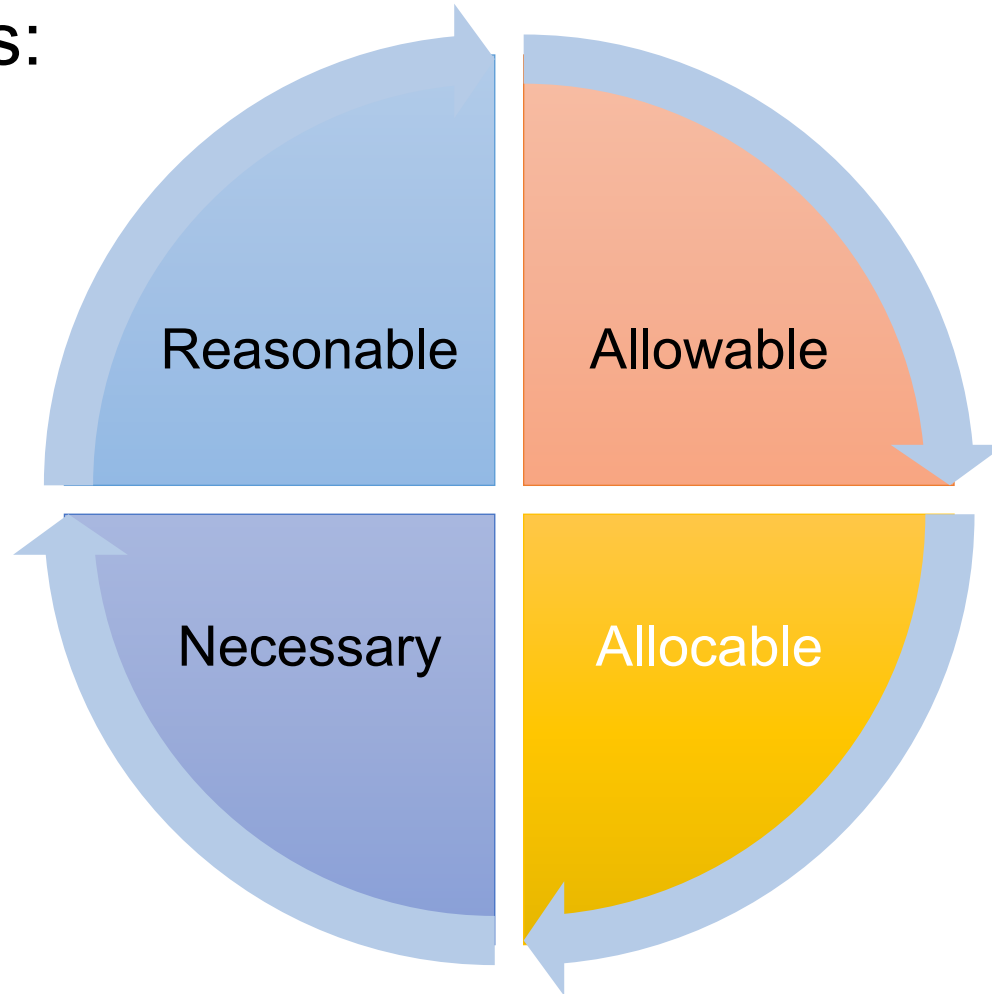

Grant Applications: Completing a Detailed Budget Narrative & Justification

Four cost principles:



Two Questions to Ask Yourself:

- How does the requested cost directly align with the project goals?
- Can I describe how the cost is allowable, allocable, necessary, and reasonable?

The project's budget should be a direct translation of the project's goals, in fiscal terms.

Reporting Potential Fraud, Waste, and Abuse, and Similar Misconduct

The subgrantee must promptly refer to the DOJ Office of the Inspector General (OIG) any credible evidence that a principal, employee, agent, subgrantee, contractor, subcontractor, or other person has, in connection with funds under this award -- (1) submitted a claim that violates the False Claims Act; or (2) committed a criminal or civil violation of laws pertaining to fraud, conflict of interest, bribery, gratuity, or similar misconduct.

VS VOCA-Supported Grants

1. **Victims Services Grant Program (VSGP)** (competitive)
 - 2nd quarter financial reports are due 1/15/2026
 - 2nd quarter status reports are due 1/15/2026 using an Excel based template (attached to the funding opportunity and sent via OGMS)
 - State Fiscal Year 2027 funding is contingent upon submitting a grant continuation application. DCJS anticipates opening the application process soon in OGMS. Only current subgrantees will be eligible to apply for continuation funding at levels equal to or less than their current award amount.

VS VOCA-Supported Grants

2. VSGP for Sexual and Domestic Violence Services (SDVS) (non-competitive)

- 2nd quarter financial reports are due 1/15/2026
- 2nd quarter status reports are due 1/15/2026 in OGMS and PMT (if PMT problems, email Anya.Shaffer@dcjs.virginia.gov)
- Reminder about the SGF used as match: subrecipients are required to utilize a certain amount of these matching funds during the grant period, in order to meet the match requirement, or they may be responsible for repaying some federal funds. Contact us if you have questions.
- State Fiscal Year 2027 funding is contingent upon submitting a grant continuation application. DCJS anticipates opening the application process soon in OGMS. Only current subgrantees will be eligible to apply for continuation funding at levels equal to or less than their current award amount.

VS VOCA-Supported Grants

3. Victim Witness Grant Program (VWGP)

- 2nd quarter financial reports are due 1/15/2026
- 2nd quarter status reports are due 1/15/2026
- State Fiscal Year 2027 funding is contingent upon submitting a grant continuation application. DCJS anticipates opening the application process later this spring. Only current subgrantees will be eligible to apply for continuation funding at levels equal to or less than their current award amount.
- Continue to forward VSDCS technical assistance and enhancement requests to VictimsServicesTA@dcjs.virginia.gov.

VS VAWA-Supported Grants

4. Sexual Assault Services Program (SASP)

- Quarterly financial & status reports are due 1/15/2026
- Annual reporting in VAWA MEI tool is due 1/21/2026
- New SASP grant period started 1/1/2026
- Signed SOGAs are due by 2/10/2026
- Grant funds may not be expended until SOGAs are signed and returned

VS VAWA-Supported Grants

5. Virginia Services, Training, Officers, Prosecution (VSTOP)

- CY 25 quarterly financial reports are due 1/15/2026
- CY 25 final report (claim) due 2/15/2026
- CY 25 VSTOP Annual Report due 2/9/2026 via the federal web-based system
 - ***Please see OGMS correspondence and email sent on 1/5/2026 for more information***
 - ***VSTOP grantees are no longer required to complete a biannual report in January***

VS VAWA-Supported Grants

5. Virginia Services, Training, Officers, Prosecution (VSTOP)

- CY 2026 Continuation Grants
 - One year award period 1/1/26-12/31/26
 - SOGAs were uploaded to OGMS in December 2025
 - Please complete all Encumbrances by the due date indicated
- CY 2026-2027 Competitive Law Enforcement Grants
 - Two-year award period 1/1/26-12/31/27
 - SOGAs were uploaded to OGMS in December 2025
 - Please complete all Encumbrances by the due date indicated
 - VSTOP New Director Orientation (NDO) will occur in February 2026

Other Funding Sources

6. Virginia Sexual and Domestic Violence Victim Fund (VSDVVF)

- 2nd quarter status and financial reports are due on 1/15/2026
- All grantees will report directly into OGMS
- PDF uploads are no longer required!
