## **Sanisha Bailey**, *Medicolegal Death Investigator Supervisor, Office of the Chief Medical Examiner Central District*

Sanisha Bailey is the Medicolegal Death Investigator Supervisor for the Central District Office of the Chief Medical Examiner (OCME). She moved to Virginia from North Carolina in 2010 as a part time investigator and was quickly able to secure a full time position. Ms. Bailey is board certified by the American Board of Medicolegal Death Investigators. As an investigator for OCME she has personally investigated hundreds of deaths in Virginia. Additionally, Ms. Bailey has trained new investigators, forensic pathology fellows, and local medical examiners in the field of death investigation. She is a guest lecturer at Virginia Commonwealth University, where she hopes to interest undergraduate forensic science students in medicolegal death investigation. Ms. Bailey holds a Master in Forensic Science from the George Washington University and B.A. in Psychology and Criminology from North Carolina State University.

## **Jeffery Gofton, MD**, *Assistant Chief Medical Examiner, Office of the Chief Medical Examiner Central District*

Dr. Jeffery Gofton returned to the Office of the Chief Medical Examiner in August 2016, after a brief hiatus in Canada. He currently is an Assistant Chief Medical Examiner at the Central District Office of the Chief Medical Examiner. Prior to his sabbatical in Canada, Dr. Gofton was an Assistant Chief Medical Examiner at the OCME's Tidewater District. He originally came to Virginia from Oklahoma, where he was the Chief Medical Examiner. Dr. Gofton is board certified in anatomic and forensic pathology. He is a graduate of St. Georges' University School of Medicine. Over his career, he has performed more than 3,000 medicolegal autopsies. Dr. Gofton has been involved in the training of medical students, pathology residents, forensic pathology fellows, and medicolegal death investigators.

## **Corine (C.T.) Moulton**, *Detective, Henrico County Police Division*

C.T. Moulton is a Special Victims Detective for Henrico Police Division where she has been investigating sex offenses and other forms of abuse exclusively for five years. During her 20 year law enforcement career, Det. Moulton has been recognized for her work as a team member, receiving the Henrico County Police Division Meritorious Award twice. She is a member of the Henrico County Child Advocacy Center Multidisciplinary Team, whose work was recognized as the best in the state in 2015. In addition to being an active team member, Det. Moulton collaborates with professionals from social services, advocacy groups, hospitals, mental health agencies, and the prosecutor's office during an investigation. Det. Moulton has been a Virginia Department of Criminal Justice Services certified instructor for over 20 years, providing in-service and roll-call training to fellow officers and instruction to recruits in the basic academy. Specifically, she created and taught a two-hour in-service block about responding to calls for service involving sex offenses and child abuse, highlighting the role of first responders to these types of crimes and ways to interact with victims who recently experienced trauma. Det. Moulton also volunteers to speak to citizen groups of adults and school age children on topics that range from fraud to the dangers of the internet.

## **Nancy Oglesby**, *Domestic and Sexual Violence Resource Prosecutor, Commonwealth's Attorneys' Services Council*

Nancy Oglesby has been a career prosecutor in the Commonwealth of Virginia for 19 years. She is currently Virginia's Domestic and Sexual Violence Resource Prosecutor. Ms. Oglesby has handled thousands of domestic violence, child abuse, and sexual assault cases. In addition, she has provided training on these issues to many professionals including prosecutors, law enforcement officers, advocates, medical professionals, and forensic interviewers. She has been appointed by four Virginia Governors to statewide advisory boards, commissions, and task forces devoted to combatting domestic and sexual violence. Ms. Oglesby also served a key role in the

development of the Virginia Department of Criminal Justice Services' model law enforcement policies related to domestic and sexual violence. In 2011, she was chosen by the Virginia Association of Commonwealth's Attorneys to receive the Virginia S. Duvall Distinguished Juvenile and Domestic Court Prosecutor Award. She also was recognized in 2012 as the Outstanding Woman of the Year in the area of Law and Government by the Richmond YWCA. In 2015, Ms. Oglesby cofounded Justice 3D, a company that offers training to allied professionals nationally on issues of child abuse, domestic violence, and sexual assault.

**Edwin Schuster, *Child Protective Services Program Consultant, Virginia Department of Social Services***

Edwin Schuster has worked in the Virginia social services system since 1981 at both the local and state level. The focus of his work has been in child welfare services. In his current position of Human Services Program Consultant, Mr. Schuster has been involved in the development of social service policy and processes as well as providing consultation to local agencies in providing child protective services to the citizens of Virginia. Mr. Schuster has been the facilitator of the Northern Region Child Fatality Review Team since 2012.
