Re: 2025 Firearm Violence Intervention and Prevention Grant Program

The Purpose of the 2025 Firearm Violence Intervention and Prevention Grant Program is to support the implementation of strategies that will result in the reduction of violent crime within the Commonwealth of Virginia while implementing effective and sustainable intervention and prevention programming to interrupt and prevent local cycles of violence. Eligible applicants under this solicitation were nonprofit organizations and local units of government. Because other funding sources were specifically available for law enforcement offices and prosecutor offices, these entities were specifically excluded from this solicitation.

The applicants were required to present clear plan for sustainability. Applicants seeking to expand or replicate an existing project had to demonstrate progress and success within the existing undertaking.

DCJS received 31 applications totaling \$5,778,350.71. DCJS anticipated that approximately \$2,500,000, would be available through this solicitation. After grant reviews, DCJS recommend approval of 20 grants totaling \$2,447,724.50.

Eleven applications are recommended for denial. Out of the 11 applications, nine applications had insufficient information for approval and two applications were deemed ineligible.

In summary, DCJS staff request approval to fund 20 projects for a 24-month period (7/1/24-6/30/26) totaling \$2,447,724.50, using State General Funds allocated for this purpose.
