Re: American Rescue Plan Act (ARPA) for Sexual and Domestic Violence Services, Non-Competitive Applications for State Fiscal Year 2025

The purpose of the American Rescue Plan Act (ARPA) for Sexual and Domestic Violence Services grant program is twofold:

1. ARPA funding comes from Coronavirus State and Local Fiscal Recovery Funds (CSLFRF). The primary purpose of CSLFRF funding is to provide state, local, and Tribal governments with the resources needed to respond to the pandemic and its economic effects and to build a stronger, more equitable economy during the recovery. In accordance with the CSLFRF Final Rule, these funds may be used by eligible programs to respond to the increased incidents of sexual and domestic violence during the COVID-19 pandemic.
2. Additionally, in accordance with state budget language, these funds must be awarded to sexual and domestic violence (SDV) organizations to offset reductions in Victims of Crime Act (VOCA) funding in State Fiscal Year (SFY) 2025.

For SFY 2025, DCJS staff **request approval to award \$3,365,679 in federal ARPA funds to 54 sexual and domestic violence organizations that saw a decrease in available VOCA funding for their core services.**

DCJS staff proposes ARPA awards that will ensure level core service funding in SFY 2025 to that received in SFY 2024. DCJS provided each agency with the amount needed for level funding and applicant agencies submitted applications based on that amount. This was a non-competitive funding opportunity, and applications were not scored. DCJS staff reviewed applications to ensure requested amounts were equal to or less than the predetermined amount and that funds were requested for allowable purposes only.

In summary, DCJS staff **request approval to fund 54 projects** for the 12-month period (7/1/2024–6/30/2025), **totaling \$3,365,679**, using federal ARPA funds allocated for this purpose.
