The purpose of the Pre-Release and Post-Incarceration Services (PAPIS) Grant Program is to support PAPIS programs in providing direct services to incarcerated individuals nearing release into the community or previously incarcerated individuals living in the community. This grant is intended specifically to facilitate case management and coaching, reentry success planning, treatment, and referrals. It also provides resources to meet the basic needs of reentering individuals, such as transitional housing, and employment readiness and placement for individuals returning to the community from prison or a local or regional jail. PAPIS is funded by state general funds.

No applications were denied. DCJS staff recommends funding all PAPIS programs at FY2025 level funding.

The majority of applicant funding requests were allocated towards personnel and supplies/other expenses needed to successfully implement and carry out grant activities. These include transportation assistance, emergency housing assistance, technology needs, course materials, assistance with obtaining identification documents, wellness and hygiene kits,

printing, and office supplies. Grant funds were also requested to support travel and mileage expenses for reentry professionals associated with the PAPIS program.

In summary, DCJS staff request approval to fund nine (9) grant applications for the 12-month period (7/1/2025 – 6/30/2026), totaling \$3,596,429 using state general funds allocated for this purpose.

The Northern Neck Regional Jail prerelease reentry program will provide many types of transitional services to adult offenders, including substance abuse/mental health referrals to in-house and community counselors, anger management, local medical care information, vocational classes, and education classes prior to their release from Northern Neck Regional Jail. Follow up contacts are attempted upon release. The program's goal is to provide reentry services to individuals who are being released from jail back into the community, and have been assessed as medium to high risk. Some examples of services offered are release planning, housing, obtaining ID's, employment and Medicaid registration. Our facility, has a QMHP to provide case management and counseling to incarcerated individuals.	VA CARES, Inc., provides pre-release and post-release reentry services through 8 direct service sites providing services in 26 cities and towns and 30 counties across Virginia. Pre-release services focus on case management and reentry planning, while intensive post-release reentry services include a standard reentry program using Carey Guides and peer support groups, educational workshops, job readiness and job placement assistance, whole family counseling, mental health referrals and more. Other evidence-based services include Motivational Interviewing, comprehensive needs assessment, and the Offender Screening Tool (OST).	STEP-UP Incorporated, provides pre-release and post-incarceration services to solution and non-volcent offenders in jails and state prisons. Our staff, including our Peer Recovery Specialist, meet with participants prior to release to ready them for needed services to make a successful transition. Our service population is those who are 18 years of age & up. Supportive services include housing, identification cards, social security, and birth certificates as well as clothing and equipment for employment. Coordination & collaboration are ongoing to make sure services needed are provided such as workforce training, apprenticeships, mentally physical health, and substance abuse services.
