**Nominee for Reappointment**

**Jackie Brock – Individual Experienced in Working with Children with Disabilities**

Jackie Robinson Brock earned her Bachelor's and Master's degrees in Social Work from Virginia Commonwealth University (VCU) with a concentration in Social Work Administration, Planning, and Policy Practice. She also obtained a Post Baccalaureate Certificate in Non-Profit Management from VCU's Douglas Wilder School of Government and Public Affairs. She is employed at the VCU Partnership for People with Disabilities. At the Partnership, Ms. Brock serves as a Program Specialist in Early Childhood and Health and is the Assistant Director of the Virginia Leadership Education in Neurodevelopmental Disabilities (LEND) program. She is Virginia's Workforce Collaboration Director for the Infant and Early Childhood Mental Health project. Ms. Brock currently serves as the Project Director for the I-CAN! Accessibility Project, which is a partnership project between the VCU School of Social Work and the VCU Partnership for People with Disabilities. This project seeks to increase equal access to the courts for people with disabilities. Before working at the Partnership, Ms. Brock worked with children and families in a transitional homeless shelter, and as a lead teacher in childcare settings for 10 years. Ms. Brock serves as the Board Chair for the Virginia Anti-Violence Project. Her interest areas include disability, domestic violence and sexual assault prevention, and early childhood.

**Allison Martin – Prosecuting Attorney**

Ms. Alison Martin, J.D., is currently employed as an Assistant Commonwealth's Attorney for Henrico County. Ms. Martin has twenty-one years of experience as an attorney including nine years of prosecutorial experience working in Henrico County, Richmond City and in the states of North Carolina and Oregon. She has also worked for the Richmond Public Defender's Office and several private law firms. Ms. Martin earned a Juris Doctor from Temple University, Beasley School of Law, and a Bachelor of Arts in English from William and Mary.

Ms. Martin specializes in cases involving child homicide and child physical abuse and neglect. Ms. Martin has trial experience with the most difficult types of child abuse and neglect cases including those involving child torture, starvation, physical abuse, with

subspecialties of abusive head trauma and blunt force trauma, sexual abuse, and medical child abuse.

Ms. Martin is a regular instructor on issues related to child abuse and vulnerable victims. She is one of the statewide presenters for the DCJS Child Death Investigation Protocol and presented at the Child Advocacy Center state conference for the past three years. She also conducted training related to child abuse for the Richmond area CASA programs. Ms. Martin serves on a variety of committees and is a member of the Henrico County Child Abuse Multi-Disciplinary Team (MDT) and recently reestablished the Henrico County Elder Abuse MDT. She currently serves as a member of the City of Richmond's Committee on Aging and served as a CASA board member for a local program in the state of Oregon.

I would like to invite your consideration for nomination to the Court Appointed Special Advocate/Children's Justice Act (CASA/CJA) Advisory Committee. You were recommended as a potential candidate to serve on the committee in the role of an **attorney, specifically one who is involved in the prosecution of child abuse cases.**

This committee advises the Department of Criminal Justice Services on two separate programs. Pursuant to the *Code of Virginia* § 9.1-151, the Criminal Justice Services Board (CJSB) will make appointments to the CASA Advisory Committee. Additionally, language for the federal Children's Justice Act grant program (42 U.S.C. 5106c) requires development of a "task force" to include membership from specific professional disciplines. The appointments will be considered and approved by the CJSB for four-year terms beginning July 1, 2025.

As indicated, the CASA/CJA Advisory Committee advises the CJSB regarding matters related to the CASA and CJA programs. It also serves as a Citizen Review Panel for the Department of Social Services. The Advisory Committee holds quarterly meetings. Per the FOIA open meetings requirements, some meetings are in-person in Richmond and others are held virtually. Members are reimbursed for any necessary travel costs. A detailed job description is attached along with the current Three-year plan and the remote meeting policy.
