6. Requirement to report potentially duplicative funding

If the subgrantee fails to remit funds owed to DCJS, the funds will then be deemed uncollectible debt by DCJS. Uncollectible debt will be reported to the Virginia Department of Taxation Debt Set Off program, Office of the Attorney General and thirdparty collections. DCJS may add fees, fines and penalties to the original amount of the debt owed.

8. Requirement to report actual or imminent breach of personally identifiable information (PII)

25. Access to grant records

26. Performance Measurement Reporting

The subgrantee agrees to submit quarterly performance reports on the performance metrics identified by DCJS and the Bureau of Justice Assistance (BJA) and in a manner required by DCJS and BJA.

27. Documentation requirements

The subgrantee agrees promptly to provide, upon request, financial or programmaticrelated documentation related to this award, including documentation of expenditures and achievements.

28. Additional monitoring requirements

The subgrantee understands that it may be subject to additional financial and programmatic on- site monitoring, which may be on short notice, and agrees that it will cooperate with any such monitoring.

Subgrantees with a grant designation of "Planning" will be required to have bi-monthly meetings with DCJS RSAT monitor to review planning progress. Subgrantees will be responsible for scheduling and conducting the required meetings.

The subgrantee agrees to comply with DCJS grant monitoring guidelines, protocols, and procedures, and to cooperate with DCJS on all grant monitoring requests, including requests related to desk reviews, enhanced programmatic desk reviews, and/or site visits. The subgrantee agrees to provide to DCJS all documentation necessary to complete monitoring tasks, including documentation made under this award. Further, the subgrantee agrees to abide by reasonable deadlines set by DCJS for providing the requested documents.

Failure to cooperate with DCJS's grant monitoring activities may result in sanctions affecting the recipient's awards, including, but not limited to: encumbrances being placed on all active awards, referral to the Office of the State Inspector General for audit review; designation of the subgrantee as High Risk; or termination of an award(s).

29. Record retention and access

Records pertinent to the award must be retained for a period of three (3) years from the date of submission of the final expenditure report. Subgrantee must provide access, including performance measurement information, in addition to the financial records, supporting documents, statistical records, and other pertinent records indicated at 2 C.F.R. 200.333.

30. Non-Supplanting requirement

Funds made available through this award will not be used to replace federal, state, or local funds that would, in the absence of this grant, be made available for the same purposes. 31. Restrictions on "lobbying"

All properly incurred obligations must be liquidated no later than 45 days after the end of the award period. No new obligations may be made during the liquidation period. The subgrantee agrees to submit a final financial report and return all received and unexpended grant funds to DCJS within 45 days of the end of the grant award period.

34. Travel Policy

Subgrantees may follow their own established travel rates if they have an established travel policy. DCJS reserves the right to determine the reasonableness of an organization's travel policy. If the subgrantee does not have an established policy, then they must adhere to federal travel policy. DCJS allows reimbursement for actual reasonable expenses and meals according to per diem. Transportation costs for air and rail must be at coach rates.

35. Project initiation

Within 60 days of the starting date of the grant, the subgrantee must initiate the project funded. If not, the subgrantee must report to DCJS, in writing, the steps taken to initiate the project, the reasons for the delay, and the expected starting date. If the project is not operational within 90 days of the start date, the subgrantee must obtain approval in writing from DCJS for a new implementation date or DCJS may cancel and terminate the project and redistribute the funds.

36. Contract Amendments

Contract amendments must be submitted for review in the On-line Grants Management System (OGMS). These contract amendments include, but are not limited to, the following:

No amendment to the approved budget may be made without the prior approval of DCJS. No more than two (2) budget amendments will be permitted during the grant period. Budget Revision – Amendment requests, along with accompanying narrative, are to be submitted using the On-line Grants Management System (OGMS). The submission deadline for budget amendments is 45 days prior to the end of the grant period.

37. Financial Audits

The subgrantee agrees to forward a copy to DCJS of the subgrantee's scheduled financial statement audit for the fiscal year that covers the grant award period. If the subgrantee is a local government or non-profit organization and expends \$750,000 or more in federal awards (from all sources) during its fiscal year, the subgrantee is required to submit the appropriate single or program specific audit in accordance with the provisions outlined in 2CFR Part 200 Subpart F.

38. Procurement

The subgrantee agrees to provide for fair and open competition when procuring goods and services with award funds and to maintain documented procurement policies and procedures. Permission to make a sole source procurement requires the prior approval of DCJS. Any request for exemption to this regulation must be filed in writing.

39. Conflict of Interest

All subgrantees must have a written conflict of interest policy. The subgrantee certifies that it will disclose in writing any potential conflict of interest to DCJS in accordance with applicable federal awarding agency policy as required in 2 C.F.R. Part 200, Subpart E § 200.112.

40. Financial Management Systems

All subgrantees are required to establish and maintain adequate accounting systems and financial records and to accurately account for funds awarded to them. They must have a financial management system in place that is able to record and report on the receipt, obligation, and expenditure of grant funds. Subgrantees must properly track the use of award funds and maintain adequate supporting documentation including maintaining proper documentation for all paid grant and match staff and volunteer time reported. 41. Project/Program Income

Any funds generated as a direct result of DCJS grant-funded projects are deemed project income. Project income must be reported to DCJS. 43. Delegation of responsibility

Any delegation of responsibility for carrying out grant-funded activities to any entity must be pursuant to a written memorandum of understanding by which the implementing organization agrees to comply with all applicable grant terms, conditions and assurances. Any such delegation notwithstanding, the applicant acknowledges by its acceptance of the award its ultimate responsibility for compliance with all terms, conditions and assurances of the grant award.

44. Executive compensation and Employees Salaries

With respect to this award, federal funds may not be used to pay cash compensation (salary plus bonuses) to any employee of the award recipient at a rate that exceeds 110% of the maximum annual salary payable to a member of the federal government's Senior Executive Service (SES) at an agency with a Certified SES Performance Appraisal System for that year. Approval of this award does not indicate approval of any consultant rate in excess of \$650 per day. A detailed justification must be submitted to and approved by the DCJS program office prior to obligation or expenditure of such funds.

47. Employment eligibility verification for hiring under the award

- 1. The subgrantee must--
 - A. Ensure that, as part of the hiring process for any position within the United States that is or will be funded (in whole or in part) with award funds, the recipient (or any subgrantee) properly verifies the employment eligibility of the individual who is being hired, consistent with the provisions of 8 U.S.C. 1324a(a)(1).

Such testing shall include individuals released from residential substance abuse treatment programs who remain in the custody of the locality.

The subgrantee agrees that substance abuse treatment and related services funded by this award will include needed treatment and services to address opioid abuse reduction.

The subgrantee understands and agrees that strategic planning activities funded by this award must include planning on how to address individuals with co-occurring mental health and opioid use disorders.

53. Potential imposition of additional requirements

The subgrantee agrees to comply with any additional requirements that may be imposed by the DOJ and DCJS, as appropriate, during the period of performance for this award, if the subgrantee is designated as "high-risk".

54. Use of funds for Unmanned Aircraft Systems (UAS)

55. Recipient integrity and performance matters
