Re: Edward Byrne Memorial Justice Assistance Grant - Law Enforcement Equipment

The purpose of Edward Byrne Memorial Justice Assistance Grant ("JAG") funds is to allow states and units of local government, including tribes, to support a broad range of activities to prevent and control crime based on their own state and local needs and conditions. As the State Administrative Agency (SAA), DCJS has the responsibility of managing the coordination and distribution of JAG funds in a manner that supports and improves the overall criminal justice system of the Commonwealth of Virginia.

This competitive funding opportunity was open to all local and public campus law enforcement agencies. Applicants were invited to submit applications with a project to purchase equipment that improves or enhances the delivery of daily law enforcement services to the community and/or ensures the safety of citizens and officers.

For this funding opportunity, DCJS received and reviewed 127 applications. Staff is requesting the approval to award \$2,939,123.00 in federal JAG funds to seventy-one (71) Law enforcement agencies.

Twenty-three (23) applications were denied for this JAG funding opportunity.

In summary, DCJS staff request approval to fund seventy-one (71) projects for the 9-month period (7.1.2024-3.31.2025), totaling \$2,939,123.00, using federal JAG funds allocated for this purpose.

Staff continue to review thirty-three (33) additional applications that required clarification and/or budget revisions, due to proposed projects that extended beyond the grant period.
