The project will utilize the evidence-based program Living in Balance and an evidence-based web program for offenders with 6-12 months remaining to serve. The program will take place at Rustburg Correctional Unit. This is a level one field/work unit. The program will accommodate two groups of 15 every six months for a total of 60 served annually. The program elements will include the web-based Therapeutic Education Systems (TES) curriculum and the "Living in Balance" curriculum. These two curricula are complementary and provide the knowledge, skills and practice to greatly improve the post-release outcomes for substance abusing offenders.

Grant Project Description

Western Virginia Regional Jail will provide substance abuse treatment for 54 male and female inmates through Alpha, a 16 week residential program offered through Blue Ridge Behavioral Healthcare. The therapeutic community model provides group counseling, on-on-one interactions and other cognitive behavioral change activities. Upon completing Alpha, participants enroll in a 36 week intensive outpatient program for aftercare. Alpha graduates also receive reentry services such as job readiness, job placement, emergency services and mentoring.

Project Performance to Date (if Continuation)

This is the last year of RSAT funding for the Alpha program at WVRJ. The program has been consistently at capacity and Blue Ridge Behavioral Health has been consistent in providing services. Grantee provides timely and thorough progress reports each quarter.
