The Allegheny Reset Project is a collaboration between the administrators of the Allegheny Regional Jail and Allegheny Highlands Community Services Board. The project will take place at the jail and serve a minimum of 30 inmates identified as opioid users during the grant calendar year. Services will include assessment, evidence based groups to treat substance use, groups for co-occurring mental health disorders to reduce recidivism, and medication assisted treatment focused on opioid use. Post release drug free housing will be an option for a limited number of inmates. Staff involved will include licensed professional physician assistant, counselor, peer specialist, reentry case manager, nurse, and lieutenant deputy.
