Chesterfield County Schools is expanding the Restorative Justice Practices programs from four high schools (Monacan, Meadowbrook High School, L.C. Byrd High School and Manchester High School) to all middle and high schools in the county. Chesterfield County Public Schools began phasing in Positive Behavioral Intervention and Supports (PBIS) in 2010. Restorative Justice/Practices is a supplemental and complementary strategy that is used in conjunction with PBIS to address high levels of out of school suspensions, disproportionate suspension rates for black and exceptional students and the reduction of repeat offenses by providing re-entry support for students returning from suspension.

Project Performance to Date (if Continuation)

Student support personnel, counselors, psychologists, and social workers completed extensive training. Baseline disciplinary data was shared with 26 secondary principals and directors. Changes were made and supported by the offices of Student Conduct to support the implementation of Restorative Practices (RP). Restorative Practices were incorporated into the six levels of interventions in the administrative handbook. In the 2015 school year 2 "responsive" circles and 17 restorative conferences were reported. Continuous professional development in RP theory and implementation, 274 participants at 7 professional development sessions. Five sessions were held with School Level Teams (SLT) to strengthen, refresh and expand the knowledge base of previously trained staff.
