## Grant Project Description

To reduce disproportionality and disparity in the Charlottesville/Albemarle criminal justice system, the City of Charlottesville will partner with Offender Aid and Restoration/Jefferson Area Community Corrections to collect and analyze criminal justice data that will inform the development of a strategic plan with implementation strategies to address disproportionality.

## Project Performance to Date (if Continuation)

Despite the late start, the project team was able to collect relevant local data as it relates to Disproportionate Minority Contact (DMC) in the criminal justice system including data from...911, police, magistrate, jail, prosecution, courts, pretrial, local probation and state probation/parole. Most recently, the Albemarle-Charlottesville Regional Jail provided the consultant (JMI) with a decade (CY2007-2016) worth of booking data, including date, charge (type and level), race, gender and jurisdiction. This data set also allows for the calculation of length of stay and bed days expended by race. The data set has been successfully transferred to JMI for analysis. The grant planning team has met 14 times since receiving the grant award to develop the research process and oversight structure, including four meetings with JMI. This work has culminated in the guiding language of the Purpose Statement, and in the creation of the Steering Committee. Preliminary data analysis has been conducted by the Criminal Justice Planner, providing a framework for the more detailed analysis to be conducted by JMI.

### Grant Project Description

The City of Charlottesville in partnership with Charlottesville City Schools is requesting funding to continue the implementation of the Check and Connect Student Engagement Program. The program is designed to prevent truancy and early school withdrawal with the objectives of reducing delinquency and disproportionality in the local juvenile justice system for students in the 8th-10th grades. The program will address school behavior and attendance issues at Charlottesville High School and Buford Middle School. The Check and Connect Coach will work with 20 students and their families who are referred to the program by school attendance teams.

### Project Performance to Date (if Continuation)

The program experienced a delay in implementation due to a lengthy hiring process caused by an extensive background check. The Check and Connect Coach has offices at both Charlottesville High School and Buford Middle School, and serves on the attendance team of both schools. Due to the delayed implementation only 5 clients were enrolled in the program. Three participants improved their attendance. None of the program participants received out of school suspensions or expulsions and none of the program participants received referrals to the juvenile justice system.

### Grant Project Description

The Department of Juvenile Justice is requesting continuation funding to provide training for DJJ line and supervisory staff in the court service unit setting. Approximately 60 additional staff from Court Service Units in Virginia Beach and Richmond will be trained in Effective Practices in Community Supervision (EPICS). Funding for this project will allow the agency to provide booster training for DJJ staff previously trained and certified to deliver the EPICS Curriculum. The EPICS Train the Trainer Booster Course, will be provided for staff members who have been selected to be DJJ trainers so that the agency can sustain an effective EPICS training capacity. The curriculum has been updated and three DJJ staff who served as trainers have either left the Department or have been transferred to other units.

### Project Performance to Date (if Continuation)

The goal of providing EPICS training to 60 additional court service unit staff was met. Funding supported two EPICS sessions for 60 court service unit staff from Roanoke County, Roanoke, Staunton, and Manassas. There were no problems encountered during the grant year. The agency will build on the success of the project to date and begin to institute regional based learning activities designed to increase proficiency and measure model fidelity.
