### Grant Project Description

Funding fully supports the salary and travel related expenses for the two staff members responsible for assuring Virginia's compliance with the core requirements of the JJDP Act, Jail Removal, Sight and Sound Separation, the Deinstitutionalization of Status Offenders. In addition funding will support 20% of the Juvenile Justice Specialist's salary for the coordination of activities in Virginia that involves the other core requirement, Racial and Ethnic Disparities. DCJS is required to make annual reports to the Administrator of Office of Juvenile Justice and Delinquency Prevention on the results of our monitoring and compliance efforts. The administrative funds available from OJJDP are not sufficient to fully staff the JJDP work. Shifting the compliance functions from the administrative portion of the grant, to grant funds, enables Virginia to continue to comply with the JJDP Act and its administrative requirements.

### Project Performance to Date (if Continuation)

.In the first quarter, of FFY 2020 (September 2019-December 2019), site visits were made to 3 courthouses, 7 jails, 8 lock-ups and 21 juvenile detention centers. Compliance monitor Stables completed the OJJDP Compliance Monitoring Annual Report and which was submitted for internal review prior to submission to the Office of Juvenile Justice and Delinquency Prevention because of the COVID-19 pandemic, the due date for the report was changed moved to April 13, 2020. During the 2nd quarter of FFY 2020, due to the pandemic, all non-essential travel was cancelled, meetings have been restricted to no more than 10 participants, and department personnel were assigned to working from home. OJJDP has not issued any guidance regarding using video or other technology to conduct compliance monitoring. In addition, many facilities that hold juveniles have restricted entry.
