Local probation supervision is provided in accordance with, and under the authority of, the Comprehensive Community Corrections Act for Local Responsible Offenders. Pretrial investigation services and the supervision of defendants are provided through this project in the Cities of Bristol, and Norton, and the Counties of Buchanan, Dickenson, Lee, Russell, Scott, Smyth, Washington, and Wise. Pretrial investigation services and supervision are provided under the authority of the Pretrial Services Act. The application requests funds for staff to supervise probationers and defendants and perform pretrial investigations, administrative staff, drug testing supplies, treatment and training for probationers, and standard office operating expenses. Supervision fees are collected.
