Trained community volunteers are court appointed to gather information, which is then relayed to the court in a CASA report to include recommendations for services and placement recommendations. CASA also monitors all services ordered by the court by verifying that the services are in place and reporting back to the court regarding progress.

We served 219 children (42 new children). 42 new volunteers were trained and 54% of volunteers retained. 4 pre-service and 123 in-service trainings were held, with 117 volunteers attending in-service training. 79% of recommendations were accepted.

The Executive Director's role is necessary and required by DCJS regulations to ensure high-quality fiscal, staff and program management, and the Case Manager positions are critical to ensuring that CASA volunteers receive the high-quality guidance needed to effectively advocate for child victims of abuse and neglect. This grant will also help pay our rent (using state funds). All of these expenses are critical to our ability to provide effective, meaningful service to child abuse and neglect victims.

In FY20, 54 volunteers served 152 children (63 new). We trained 14 new volunteers in 2 pre-service sessions, offered 4 in-services attended by 41 volunteers; retained 58% of volunteers; and judges accepted 66% of our recommendations and rejected 4%.
