Re: Bryne/ JAG Regional Criminal Justice Training Academy Equipment Grant Program

The purpose of Edward Byrne Memorial Justice Assistance Grant ("JAG") funds is to allow states and units of local government, including tribes, to support a broad range of activities to prevent and control crime based on their own state and local needs and conditions. As the State Administrative Agency (SAA), DCJS has the responsibility of managing the coordination and distribution of JAG funds in a manner that supports and improves the overall criminal justice system of the Commonwealth of Virginia.

This formula-based funding opportunity was open to Regional Criminal Justice Training Academies only. Many factors were utilized, including a base allocation, financial stress, and number of officers trained to determine the maximum amount of the award for each agency.

For this funding opportunity, DCJS received and reviewed applications from ten (10) of the eleven (11) eligible regional academies. Staff is requesting the approval to award \$854,880.00 in federal JAG funds to 10 Regional Criminal Justice Training Academies.

No applications were denied for this JAG funding opportunity. One eligible academy did not apply for internal reasons.

In summary, DCJS staff request approval to fund ten (10) projects for the 9-month period (4.1.2024-12.31.2024), totaling \$854,880.00, using federal JAG funds allocated for this purpose.
