## School Shooters in Higher Education // Hampton Ballroom (3rd Floor)

This presentation examines college and university shooters from several angles, including differentiating random vs. targeted attacks, exploring psychological types (psychopathic, psychotic, or mixed), and identifying the many life factors and stresses that put them on the path of violence. A better understanding of the perpetrators will help prevention efforts by aiding staff in recognizing students or staff who present a risk of impending violence.

A student's message is vague but ominous: "I'm coming for her." But is that enough to pursue a case? Do you warn the victim, a fellow student, who lives on the same floor in a local dormitory? This program will discuss the factors and surrounding circumstances that will enable you to make that type of decision. Incorporating criminal law, psychological research, and case examples, this program will discuss modern methods of investigating and utilizing circumstantial evidence, to distinguish danger from drama in academic settings. This program will analyze what type of conduct is likely to trigger a campus/academic review, whether the conduct rises to the level of criminal culpability and explore alternative methods of managing threatening behavior.

# Trauma-Informed Interviewing // Hampton Ballroom (3rd Floor) — Room I

This course will provide campus law enforcement, advocates, administrators, faculty, and stakeholders with the knowledge they need to strengthen their approach to sexual violence cases on campuses. Participants will learn about trauma-informed victim interviewing. This presentation will introduce the science behind trauma's impact on our brain, the parts of the brain that are impacted when someone experiences trauma, and examine how trauma impacts a victim's emotions, behaviors, and memory. Participants will receive information and strategies for conducting trauma-informed interviews, conducting investigations, and discuss some of the unique challenges addressing alcohol facilitated sexual assault.

# Jared Loughner and James Holmes: Former Students Who Committed Non-School Attacks //

# Not All is Fine with Clery // Hampton Ballroom (3rd Floor) — Room I

Ed Purchase, The University of North Carolina System

Another year, another campus hit with a multi-million-dollar fine for failing to comply with the Jeanne Clery Act. With each fine levied, the U.S. Department of Education (ED) spells out why and how the campus fell short in the hope that other Colleges and Universities will learn and modify their compliance activities accordingly. However, despite that information, campuses are making the same mistakes again and again. ED is realizing their fines are not enough of a deterrent and they are beginning to reach for the other sticks in their bag. What if I told you \$62,689.00 per infraction was the least ED could do to a campus found out of compliance with Clery? What if I told you there are multiple stops on the road to total cessation of Federal Financial Aid/Title IV? That each stop along the way led to greater and greater strains on institutional resources and increasing administrative obligations? Come learn about all the sticks ED has in its bag and leave prepared to inform your leadership just how much an ounce of prevention is worth over a pound of the cure.



# Campus Challenge: Investigating and Prosecuting Sexual Assault by Intoxication in an Educational Setting // Hampton Ballroom (3rd Floor) — Room II

Cases of sexual assault by intoxication involve sensitive and often explosive evidence, which require a trauma-informed approach to working with victims. This is especially true in cases of campus sexual assault, where the suspect and victim are often acquainted, and share the same social circle. Addressing the process of reporting sexual assault by intoxication against known perpetrators, incorporating research on the reluctance for victims to come forward in academic settings, this program will examine issues of consent, credibility, investigative tactics, and juror expectations, and how to provide support and assistance to often severely traumatized victims. Recognizing the value of collaboration, it will discuss how to effectively partner with investigators, advocates, and other service providers in providing a unified support system to help victims become survivors.

# Understanding Mass Violence and Promoting Recovery for Survivors on Campus //

Our worst-case scenario of an individual targeting our campuses in the most unexpected ways has become an increasing reality. What do we know about those that commit mass violence? What do survivors need, both short and long term? How can we best plan and prepare for these kinds of nightmare scenarios happening in our communities and on our campuses? This session will discuss the current trends and research regarding the prevalence of mass casualty events and those that perpetrate these crimes. We will utilize case examples of what has worked and what lessons we have learned in responding to mass violence events, with a special focus on campus violence. Most significantly, we will ensure that campuses and communities know what services and resources are available following a criminal mass casualty event or critical incident to best support survivors. Lastly, we will identify strategies that promote resilience and recovery.



#### Active Attack Response — Solo Officer Response\* // Hampton Ballroom (3rd Floor) — Room VI

Adam Keene, Virginia Department of Criminal Justice Services

This course of instruction is designed to provide the solo officer (off-duty/plain clothes /uniform) with the mind set on why it is imperative to isolate, distract, or neutralize an armed threat during an active attack, without delay or waiting on responders. This course covers the response priorities of "Stop the killing" and "Stop the dying", levels of intervention, deadly force policies and case studies, options for mitigating the occurrence of blue-on-blue shootings, concepts, and principles of post engagement priorities of work, and basic incident management.

A Predator Hiding in Plain Sight: An Inside Look at the Victim-Centered, Offender-Focused, and Trauma-Informed Approach to the Larry Nassar Case // Hampton Ballroom (3rd Floor)

Andrea Munford, Michigan State University Police Department

In this session you will hear from the lead investigator from the Larry Nassar case, the former sports doctor convicted of sexual abuse of hundreds of women and girls, mostly under the guise of medical treatment, as he hid in plain sight – behind the mask of respect, education, prestige, and Olympic and collegiate glory. Deputy Chief Andrea Munford will discuss how using trauma-informed, victim-centered, and offender-focused practices helped to empower hundreds of women to come forward and speak their truth while the world watched. The presentation will offer insight on how to conduct a large scale, multi-victim investigation while navigating significant media. Munford will share key investigative techniques, including how to improve multi-disciplinary communication and collaboration with Title IX investigators, plaintiff's civil attorneys, and investigative journalists. The presentation will also discuss how a unique plea agreement was fashioned that resulted in an unprecedented and empowering sentencing hearing, as well as how to best support victims who are dealing with trauma uncovered decades after a crime.

Mental Health Intervention, Suicide Prevention, and Violence Risk Management: Three Peas in a Pod or Uneasy Bedfellows? // Hampton Ballroom (3rd Floor)

Mental health problems are often linked to violence risk, and mental health treatment to violence risk reduction. This formulation has the benefit of allowing people with different perspectives to come together and pursue shared goals. However, the rationale behind these linkages is based in both accurate and inaccurate appraisals of the nature of those associations. Productive policy and supportive responses to students in crisis or suspected of being at risk for violence will come from a solid understanding of the relationship between mental health problems and violence risk; this presentation will provide information on the nature of that relationship. Audience members will then be challenged to consider the tensions and conflicts that may arise when navigating a landscape that involves real and perceived threats, and shared obligations to individuals and the public's safety.


