8:30 AM-9:30 AM	What You Think the Threat Looks Like Might Not Be Accurate Sheriff Michael Neal, Monroe County, Arkansas Sheriff's Office
	Sheriff Michael Neal began his career in law enforcement more than 21 years ago at the very department he still serves in Monroe County, Arkansas. Throughout his career as both Reserve Deputy, Game Warden and now Sheriff, he's survived five shootings. In 2010, he was involved in an active shooter situation where the criminals shot two other officers and left the scene. A manhunt ensued – Sheriff Neal encountered them a few miles down the road. Knowing that he needed to stop them from leaving the parking lot, he proceeded to ram the car carrying the two active shooters with his truck at 55 miles per hour. After the significant impact, while still holding the steering wheel with one hand and a rifle in the other, Sheriff Neal engaged in fire with the criminals through the front windshield of his truck. After the fire ceased, Neal's truck, which is on display at the National Law Enforcement Museum in Washington, DC, was peppered with 12 rounds of AK-47 ammo. He suffered significant injuries including shrapnel damage down the length of his entire leg, a piece of glass lodged in his eye, and blown eardrums. However, his bravery and quick action in stopping these criminals did not go unnoticed. Sheriff Neal received a total of 42 awards with one of the highest honors being the Congressional Medal of Valor. During this keynote he will share details of the incident and tips for mental preparedness for the threat you don't see coming.

	The Community Awareness Briefing (CAB) will provide a foundational understanding of the threat of targeted violence and terrorism, identify ways communities can protect themselves and their loved ones through partnerships across every level of government, and effective prevention and intervention strategies. The CAB looks closely at risk and protective factors to determine the likelihood an individual will commit an act of violence and identify ways to decrease the probability of violent outcome. Many individuals who are planning to engage in targeted violence display threatening or concerning behaviors that are observable to others. Utilizing a proactive, evidence-based method of investigation, analysis, and management that focuses on an individual's patterns of thinking and behavior, can determine whether, and to what extent, an individual may be moving towards an act of intended violence, either self-directed or towards others.

	Members from a broad range of organizations (law enforcement, corrections, business, education, houses of worship, law, health care, etc.) are increasingly aware of subjects that may present an ongoing risk for concerning or violent behaviors. These may include but are not limited to incidents of targeted violence or terrorism impacting schools, campuses, workplaces, or other community settings. These individuals can be highly disruptive, not only in the school, campus, or workplace settings, but in the community at large. Incidents from around the world have underscored the ongoing need for collaborative and integrated strategies to prevent targeted violence where possible, and to mitigate risk of harm where necessary. More and more communities are developing community-wide approaches to identify, assess and manage potential threats in lawful and collaborative ways. This session will provide an overview of community- based threat management approaches and considerations for program implementation.

Digital Threat Assessment® (DTA) is an invaluable training tool for Safety/ Threat Assessment teams as it supports the accuracy of our procedures/processes related to Behavioral Threat Assessment and Management. During this keynote, participants will gain a better understanding of how to identify digital leakage, assess individuals evolving along the pathway to violence, determine the validity of online threats, learn best practices for proper data collection, and how to proactively reduce the potential of violence within your community. Soon to be revolutionized after the tragedies at Columbine and Virginia Tech, and expanded further after Sandy Hook and Parkland, the method is used increasingly today to thwart attacks brewing within American communities. In this keynote, Mr. Follman will discuss issues of public perception, the role of mental health, and his other ongoing research into the work of preventing targeted attacks. Included will be an account of how a threat assessment team successfully guided a troubled high school student away from potentially committing violence.

	67 disrupted plots against K-12 schools from 2006–2018. The key findings of the study are clear and consistent: Individuals contemplating violence often exhibit observable behaviors, and when community members report these behaviors, the next tragedy can be averted. The Secret Service encourages its educational, medical, and public safety partners to review the information within, and use it to guide best practices for maintaining a safe and healthy learning environment for all children.

	Tony Pustizzi, Chief of Police (retired), Coral Springs Florida Police Department
	On February 14, 2018, a former student entered Marjory Stoneman Douglas High School in Parkland, Florida, fatally shot and killed 17 innocent people and wounded 17 others. This tragedy was the ninth deadliest mass shooting event in the history of the United States and the third deadliest school massacre at that time. Marjory Stoneman Douglas High School, located in Parkland, Florida, is a 45-acre campus comprised of 13 buildings. On the day of the shooting, there were 3,200 students and 200 staff members on campus. Chief Tony Pustizzi oversaw the Coral Springs, Florida Police Department at the time of the massacre. He and his officers played an extremely significant role in the response to that attack. Here, Chief Pustizzi will share his unique front-line perspective on that incident and detail valuable lessons learned.

	The DCJS Active Attack Program (AAP) exists to help achieve the goals of preparedness and protection for the entire Commonwealth. This statewide initiative promotes safety preparedness through the "Whole Community Approach." The days of citizens "hiding and hoping" until help arrives are no longer an acceptable form of mitigation. The Civilian Response and Casualty Care (CRCC) is a course designed and built on the Avoid, Deny, Defend/Run, Hide, Fight strategy developed by ALERRT in 2004, which provides strategies, guidance, and a proven plan for surviving an active shooter event. This presentation will provide an overview of these key components, combining the civilian response with the Stop the Bleed Campaign, which empowers civilians to provide life-saving medical aid before first responders ever arrive.

In a morning meeting on December 14, 2012, she heard alarming sounds outside of the main office. She, along with the Principal and School Psychologist, confronted the unknown. Although wounded multiple times during the attack, Natalie survived her injuries. She now serves as Principal in a K-4 elementary school in Connecticut. Since the tragedy, she works with groups around the country to discuss resiliency in the face of adversity, the importance of communication and collaboration when developing safety plans, and the necessity for social-emotional learning to be embedded into our daily practice as educators.
