2. Approval of past minutes.

3. Division Update.

Frank Pitzer, Field Inspections and Audit Manager for the Division of Law Enforcement within the Department of Criminal Justice Services (DCJS), provided an update on recent activities within the division.

Curriculum Development Team (CDT)

The CDT was staffed by one person: Brandon Williams. Until recently when the team increased by three new staff members: Dannie Anderson, Derek Davis, and Nicholas VanValkenburgh.

Current focus areas include:

DOC corrections officer compulsory minimum training standards which become effective April 1, 2026, and the new law enforcement compulsory minimum training standards which become effective January 1, 2027.

Law enforcement Model Lesson Plan classroom material is complete except for a few high liability topics (Firearms, DT, Driving).. DT is due to be completed by the end of December. In addition, active attack is out for its final review with external subject matter experts.

Most material has been sent out for review with virtually no negative responses from academies and all deliverables are expected to be complete by early May of 2026, with the anticipation of starting 2 academy pilots in June/July of 2026.
