### I. Call to Order and Approval of Minutes

Chairman Chief Craig Branch called the meeting of the Criminal Justice Services Board (CJSB) to order at 11:00 a.m. A guorum of the Board was present.

Ms. Mary Biggs participated through electronic communication pursuant to *Virginia Code* § 2.2-3708.2(A)(1)(b) due to a medical condition.

Mr. Bradley Marshall participated through electronic communication pursuant to *Virginia Code* § 2.2-3708.2(A)(1)(b) due to having court that morning and not being able to drive to Richmond in time for the meeting, from Haymarket, Virginia.

Senator R. Creigh Deeds participated through electronic communication pursuant to *Virginia Code* § 2.2-3708.2(A)(1)(b) due to having court that morning and not being able to drive to Richmond in time for the meeting, from Hot Springs, Virginia.

# II. Approval of Minutes

Superintendent William Smith made the motion, seconded by Mr. Jagdish Katyal, to accept the minutes of the May 11, 2023, meeting of the CJSB with one correction. The motion passed unanimously.

# III. Director's Report

Ms. Tracy Louise Winn Banks, Chief Deputy Director of the Virginia Department of Criminal Justice Services (DCJS) gave the following report to the Board:

- A new board member, Ms. Robin Deiulio, was identified to the Board. She is an Engineer with KBR, Inc., in Montgomery County and is filling the private citizen vacancy on the Board formerly held by Ms. Carrera.
- On June 6, 2023, following the announcement of the mass shooting at the Altria Theater in Richmond, the DCJS Victims Crisis Assistance and Response Team (VCART) Program staff immediately put Region #1 response teams on standby to assist as needed. VCART staff made direct contact with the mother/wife of the deceased victims to offer support, information, and referrals. VCART staff are in communication with the Richmond City Victim Witness Program to get victim information for those that were physically injured and those that witnessed the shooting. VCART staff will continue to coordinate with other entities to assess needs and ensure victims have access to services and resources available. In addition, they will offer assistance through individual crisis intervention, information, referrals, group crisis interventions, and assistance with applying for victims' compensation.
- DCJS launched an agency wide Learning Management System (LMS) on June 1, 2023.
   This system will make online training opportunities available to constituents across the Commonwealth.
- The Conference on Violent Crime was held in Roanoke, Virginia, June 5-7, 2023, for over 340 participants. Topics included Domestic/Sexual Violence, Effective Investigation, the Role of the Prosecutor After a Racially Motivated Mass Shooting and Fighting Fentanyl.
- The Active Attack Training Program has completed over 250 Civilian Response and Casualty Care courses in FY23 with an expectation to offer even more in FY24. The program is beginning to offer law enforcement active attack training courses and is on track to offer over 16 courses before December 2023.
- The Virginia Center for School and Campus Training Forum will take place July 25-27, in Hampton, Virginia, with over 850 participants currently registered. Over 1,000 school safety professionals are expected to attend the conference which has been offered for 22 years.

# IV. Committee Reports

### **Committee on Training**

Chief Branch called on Superintendent Smith to give a report from the Committee on Training (COT).

The COT recommended that the CJSB approve the recertification of the City of Galax as a Certified Crime Prevention Community.

Superintendent Smith made the motion, seconded by Ms. Biggs, to approve the recertification of the City of Galax as a Certified Crime Prevention Community. The motion passed unanimously.

The COT recommended that the CJSB also approve the recertification of Warren County as a Certified Crime Prevention Community.

Superintendent Smith made the motion, seconded by Ms. Biggs, to approve the recertification of the Town of Warren as a Certified Crime Prevention Community. *Recusal: Chief Maggie DeBoard*. The motion passed.

The COT recommended that the CJSB approve the recertification of Westmoreland County as a Certified Crime Prevention Community.

Superintendent Smith made the motion, seconded by Ms. Biggs, to approve the recertification of Westmoreland County as a Certified Crime Prevention Community. *Recusal: Sheriff C. O. Balderson.* The motion passed.

#### **Executive Committee**

Chief Branch turned over the meeting to Vice-Chair Bryan Porter as he gave the following updates from the CJSB Executive Committee:

#### On May 18, 2023, the Executive Committee heard the decertification appeals of:

- *Mr. Jeffrey Dense*, formerly with the Virginia State Police, and reinstated Mr. Dense as a law enforcement officer.
- **Ms. Grace O'Connor**, formerly with the Norfolk Sheriff's Office, and upheld the decertification of Ms. O'Connor as a law enforcement officer.
- *Mr. Eric Allen*, formerly with the Richmond Police Department, and reinstated Mr. Allen as a law enforcement officer.

#### **Grants Committee**

Chief Branch gave the Grants Committee report. The Grants Committee met on June 1, 2023, and made the following recommendations:

- American Rescue Plan Act (ARPA) Child Advocacy Centers (CAC) Grant Program.
   The Grants Committee approved funding in the amount of \$173,294 for 12 awards.
- American Rescue Plan Act (ARPA) Court Appointed Special Advocate (CASA)
   Expansion grants. The Grants Committee approved funding in the amount of \$343,124 in federal funds for 3 awards.
- American Rescue Plan Act (ARPA) Victims Services Grant Program (VSGP) Action Alliance grants. The Grants Committee approved an increase in funding in the amount of \$67,500, for a total award of \$499,517.
- American Rescue Plan Act (ARPA) Telehealth Programs in Rural Communities grants. The Grants Committee approved funding in the amount of \$280,000 in federal funds for two awards.
- Byrne/Justice Assistance grants (JAG) in the amount of \$1,295,580 in Federal Funds for two awards.
- Peer-Support Critical Incident Stress Management Grant Program (CISM) in the amount of \$300,000 in state funds for two awards.
- Virginia Sexual and Domestic Violence Victim Fund (VSDVVF) grant in the amount of \$1,785,303 for 43 awards using State General Funds and Virginia Sexual and Domestic Violence Victim Fund (special funds) allocated for this purpose.
  - **Victim/Witness Grant Program (VWGP) Continuations** in the amount of **\$18,049,364** for **114** awards. This is comprised of VOCA funds (\$11,918,066), State General Funds (\$943,700), and Virginia Crime Victim-Witness Special Funds (\$5,187,598) allocated for this purpose.
- Victims of Crime Act (VOCA) Department of Social Services (DSS) Child Advocacy
   Centers grant programs in the amount of \$3,987,524 in federal funds for 1 award.

A motion was made by Mr. Katyal to approve the block of grants as recommended by the Grants Committee. The motion was seconded by Sheriff Brian Hieatt. The motion passed unanimously.

#### **Nominations and Appointments Committee**

#### **Outstanding Vacancies**

It was noted that the PSSAB still has three vacant seats. The Law Enforcement Representative is vacant following Mr. Jeffrey Dodson's retirement. One Locksmith Representative and the Special Conservator of the Peace Representative seats are also vacant. DCJS is actively recruiting applicants for these vacant seats.

Mr. Ed Macon made the motion that the Board vote to approve the recommended appointments/reappointments and term limits to both the CASA/CJA and the PSSAB. The motion was seconded by Superintendent Smith. *Recusal: Mr. Katyal, Opposed: Dr. Sesha Moon.* The motion passed.

There was some discussion regarding these appointments. It was requested that bios, resumes or some other documentation regarding each individual being appointed to a committee or subcommittee be provided to all board members in the future for consideration before a full vote is taken by the CJSB.
