Welcome and Introductions

Marybeth Matthews-Adkins, Committee Vice-Chairperson, called the meeting to order at 10:35 a.m. A quorum was present. Marybeth welcomed new committee member, Sabrina Dorman-Andrew. Committee members introduced themselves.

Approval of March 5, 2025 Meeting Minutes

Senator Favola made a motion to approve the March 5, 2025, meeting minutes. Kate Hanger seconded the motion. The committee voted to approve the minutes, unanimously.

State Agency Funding Updates

- Virginia Department of Criminal Justice Services (DCJS)
 Kristina Vadas reported the following:
 - Virginia's federal fiscal year (FFY) 2024 VOCA award totals \$19,866,137, down from \$34,605,387 in FFY 2023. DCJS anticipates a similar award in FFY 2025. The FFY VOCA application has not yet been announced.
 - The Office on Violence Against Women (OVW) recently released some new grant opportunities, called a Notice of Funding Opportunity (NOFO), including NOFOs for DCJS's Sexual Assault Services Program (SASP) Formula Funding; Services, Training, Officers, Prosecution (STOP) Funding; and Improving Criminal Justice Responses (ICJR) funding. DCJS is working on these applications, which are due to OVW later this month (June 2025).
 - The following DCJS grants are in their final quarter of their respective grant cycles: Victims Services Grant Program for Competitive Grants; Victims Services Grant Program for Sexual and Domestic Violence Services (non-competitive); Victim Witness Grant Program; Virginia Sexual and Domestic Violence Victim Fund; and American Rescue Plan Act (ARPA) funding. Aside from ARPA, which completely ends 6/30/2025, these grant programs will start a new grant cycle on 7/1/2025 with new awards.
 - DCJS has two calendar year grant programs: VSTOP and SASP. VSTOP is in the second year of a two-year grant cycle. SASP is halfway through its 12-month grant cycle.
 - In response to a question concerning how DCJS will plan for reduced VOCA funding, Kristina explained that state general funds have been helpful in keeping awards level. This year, state general funds increased, which provided for increased awards. Future VOCA-supported grant awards may be decreased if state general funds are not available in the future.
- Virginia Department of Health: No report.
- Virginia Department of Housing and Community Development (DHCD) Kike Oliver reported the following:
 - DHCD's Homelessness and Special Needs Housing Unit Grant Program is in the process of closing out grants. State fiscal year 2026 awards will start 7/1/2025.
 - The Committee discussed how housing vouchers may be impacted by the pending federal budget bill. Kike referred members to William Kerner with DHCD. Some members offered that the Virginia Housing Trust Fund has been very helpful, yet there is some uncertainty with housing funds including Homeless and Special Needs funding, which support emergency shelters, rapid rehousing, and homelessness prevention.
- Virginia Department of Social Services (VDSS) Nancy Fowler reported the following:
 - VDSS Domestic Violence Underserved Populations Grant was to be posted and affective
 7/1/2025 but it was postponed and should be posted later this month (June 2025), with awards

to be active 11/1/2025. Current contracts, which are scheduled to end 6/30/2025, will be extended through 10/31/2025.

- VDSS Domestic Violence Prevention and Services Grant was renewed for one final year. There will be a new solicitation in the Spring of 2026.
- VDSS has two ARPA grants: Sexual Assault & Domestic Violence Grant and ARPA Vaccine Testing Grant. Both will end 6/30/2025.
- VDSS has some left-over ARPA funding, which they are planning to use to provide additional training to providers and purchase computer equipment for programs.
- VDSS is funding STEPS, which is a new domestic violence service provider in Virginia. STEPS is a community action agency that is serving part of the region previously served by the Southside Center for Violence Prevention (now closed) and the Powhatan Department of Social Services. STEPS will be a comprehensive service provider. DCJS is also funding sexual assault services at STEPS as well.

Past Business

• Language Access Work Group Update

Representatives from the Action Alliance were unable to attend the meeting. They asked Kristina Vadas to inquire from the Committee whether there is a continued need or interest in this work group continuing pursuit of language access improvements. The Committee discussed this question, and members were in agreement that issues remain, and they would like the work group to continue working on these challenges.

Previously the Committee asked the Crime Commission to conduct a study on the extent and gaps in language access for victims across the Commonwealth. The Crime Commission has been unable to fulfil this request due to the required work assigned to them by the General Assembly each year. Committee members agreed that a survey would be helpful, and the suggestion was made to contact a higher education school such as George Mason University or to request a JLARC (Joint Legislative Audit and Review Commission) study.

Members discussed the need for a standardized process for providing interpreters in courts across the Commonwealth and the hurdles faced by victim/witness staff in accessing interpreters.

Meeting guest Eileen Longenecker with the Office of the Executive Secretary (OES) of the Supreme Court of Virginia shared the following:

- OES has funding to support interpreters for court needs. OES can also provide interpreters at clerks' offices. They cannot support victim/witness or law enforcement interpretation needs. Victim/witness needs to seek additional funds for their own interpreters.
- OES has limited interpreters and many vacancies.
- Courts are aware of their language access responsibilities.
- OES has information on their website regarding the language access plan for Virginia courts.

- OES has "Teletalk," which is an interpretation service for after hours. OES trains magistrates and courts about this service.
- Eileen invited Committee members to speak with her about issues related to courts and OES.
- Virginia judicial system website will show what is available in terms of language services: <u>https://www.vacourts.gov/courtadmin/aoc/djs/programs/interpreters/home</u>
- OES is working on updating translated protective order forms.
- In response to an inquiry about who community members can contact about complaints or additional assistance needed, Eileen will report back.

The suggestion was made for the work group to create a document/handout about language access resources, to include the OES webpage and information about individuals' language access rights. Additionally, it was suggested that there be training on the document/handout and resources. Members also noted that even when interpretation is available, it is often not trauma-informed, which can lead to miscommunication or re-traumatization. Some clients feel uncomfortable or unsafe speaking through a third party, especially when discussing sensitive or personal issues.

Nancy Fowler also suggested that she meet with the work group to develop a new entry on language access in VDSS's Promising Practices Guide. The guide can be found here: <u>https://www.dss.virginia.gov/family/domestic_violence/ppg.cgi#community_connections</u>

• Impact of Recent Federal Actions

The Committee discussed the current impact of recent federal actions. Senator Favola asked for service provider organizations to contact her once the federal budget bill passes and help her identify any gaps and local impacts resulting from the budget bill. Claudia and Marybeth will make this request to agency directors at the Action Alliance's Directors Call in late June 2025. They will then provide Senator Favola a summary of the gaps and impacts discussed, and they will also report this information back to the Committee sometime in July.

New Business

- No new business.
- In response to a member asking how to bring up new business in the future, Kristina Vadas clarified the following: any member is more than welcome to propose new business at the meeting or before the meeting. If the request is to include new business on the agenda before the meeting, the chair and vice chair will need to approve the agenda. Other Member Announcements

- Elvira de la Cruz shared that her organization, Latinos in Virginia Empowerment Center, has opened a support group for people feeling overwhelmed by recent U.S. Immigration and Customs Enforcement (ICE) activities in Virginia. The support group is for both victims and non-victims. The support group is led by a licensed clinician.
- Committee members discussed some issues victims have encountered with increased ICE activities.
