# **Authority**:

The Department of Criminal Justice Services (DCJS) is responsible for monitoring the activities of sub-grantees to ensure that awards are used for authorized purposes and in compliance with 2 C.F.R. §§ 200.303 and 200.331, and other federal statutes, regulations, and the terms and conditions of the awards. The DCJS grant solicitation, subsequent application and statement of grant award (SOGA) contain all of the required information listed in 2 C.F.R. § 200.331 (a). In accordance with this responsibility, DCJS implemented the Grant Monitoring Policy & Procedures (effective March 2019). The policy outlines risk-based compliance methods for conducting monitoring reviews of sub-grantees to objectively evaluate fiscal and programmatic performance. DCJS utilizes several methods to assess compliance to include the risk assessment tool, monitoring plan, fiscal and programmatic desk reviews, on-site monitoring, and enhanced desk monitoring which can be performed remotely.

# Purpose:

The Enhanced Desk Review includes an analysis of the sub-grantees records (eg. grant documentation; supporting documentation of expenditures, program policies; performance data and methods to verify data collection; and other documents relevant to the award); interviews with grant-funded staff and authorized project officials to examine the sub-grantees compliance of program requirements.
