Personnel

Salaries & Benefits \$34,706

We are requesting \$34,706.00 to hire a new, part-time Residential Assistant and Community Educator to provide a variety of supportive services, shelter options and supplies which will reduce the exposure and risk of COVID-19 to domestic violence survivors. The \$34,706 represents the current salaries and benefits for two positions.

Approximately 160 hours of will be devoted to providing these services to the survivors. We will pursue additional funding for the position to increase it to a full-time position.

Travel & Subsistence \$1908.00

Local mileage reimbursement is projected at an average of 250 miles per month at 54 cents per mile for during the grant cycle. This mileage is projected to accompany out of town travel for training purposes and outreach travels to disseminate materials to DV/SV survivors living in the rural underserve areas that we serve.

Subsistence reimbursement is projected for a total of 6 days at a projected daily cost of \$48 per day. This subsistence expense will occur as a result of local and out of town trainings for meal reimbursement for a total expense of \$288.

Supplies and Other Expenses \$1500

To disseminate educational materials and resources on the precautions to prevent COVID-19, the agency will update our DV/SA educational brochures to include (COVID-19 educational information and practice drills for families to practice social distancing and hand washing drills. We will purchase 10,000 brochures @ \$569.00 and we will print COVID flyers to give out to victims and survivors that we serve in shelters, motels, and during community outreach events. We will purchase 10 cases of paper to print over 25,0000 flyers @ \$329.90 and other educational materials. Also, we purchase 6 ink cartilages for the printer@ \$601.00

Supplies \$886.00

We will purchase COVID-19 PPE's supplies and cleaning supplies to promote sanitize clean environment at the emergency shelter, children's center and the resource center.

Training Education Events \$1500 During community outreach, the Community Educator will promote healthy safe tips and prevention educational materials on COVID pandemic. In recent weeks, there has been a surge in COVID positives cases. The numbers have increased by 10% in the rural areas that we serve. Our agency did not realize how many households were lacking internet access in the rural communities that we serve, until the children needed virtual learning for home schooling. Therefore, we discovered they're without information such as the CDC's COVID health reports and links to free resources in the rural communities. By

providing the printed COVID resources and information to give away to the families, will hopefully, provide households some with knowledge of ways to stay safe and healthy during the COVID pandemic. In the trainings we will disseminate COVID education materials which will include testing sites and dates, masks, small bottles of hand sanitizer, and thermometers. The prepared kits will cost about \$8 per kit. We will purchase 167 kits with the CESF funding and will continue to purchase more when additional funding is available.

Professional Janitorial Services \$9500 The health and safety of our clients and staff is vital, we have strictly adhered to the recommendations on sanitation put forth by the CDC. We have had to increase our janitorial services to include routine deep cleaning with a special focus on high-touch surface areas at our administrative office, emergency shelter and community center.
