**Brief Project Description:**  
It is anticipated that between January 1, 2017 – December 30, 2017, victim advocacy services will be provided direct services to 25 victims of sexual assault. Services will include: Crisis intervention; advocacy and support to survivors in medical settings; short term crisis intervention counseling; and information and referral services. Funds will be used to reach underserved victims. SASP grant funds will be used to supplement existing funds and will not replace (supplant) funds that have been appropriated for the purpose of providing services to victims of sexual assault. The total number of victims served through SASP funded services during the time period of January 1, 2016- June 30, 2016 was twelve (12) victims of sexual assault.

**Budget Narrative****January 1, 2017-December 31, 2017****1. Personnel****\$7,858**

Safehome Systems staff will take turns being on call for one week at a time to provide accompaniment for sexual violence victims to the hospital and/or law enforcement agencies and may provide transportation when needed. Staff members will be on call from 5:00pm-9:00am during the week and 9:00am-9:00am on Saturday and Sunday. Staff will be paid at a flat rate of \$20 for each night they are on-call. This extra pay will be used to compensate staff members for extra time and travel required for sexual assault accompaniment and advocacy. This is an additional responsibility to respond to sexual violence victims and is not a duplication of job duties. Safehome responds to hospitals in Alleghany, Bath and Highland counties. Staff must travel between 20 – 150 miles round trip for a hospital exam. Requested SASP funds will be used to provide on call wages and FICA for our full time staff during the time period January 1, 2017 and December 31, 2017. An itemization is below:

Staff on-call costs **\$7,300**

(Nightly on-call rate: \$20 /day x 365 days a year= \$7,300 or \$1.25 per hour for 16 hours during the week or .83 per hour for 24 hours per day on the weekends. This is a total of \$1,460.00/year.

FICA **\$558**

(\$7,300 or \$140.38 a week x 7.65% =10.74 each paycheck for a total of \$558 per year.)

**Supplies**

Our request in this category is for outreach materials for the underserved population of rural victims of sexual assault. We live in a large (1,405 square mileage) isolated rural area with only 29,263 people. We have five full time staff members who must cover these 1,405 square miles to provide services. Our intention is to use a combination of radio PSA's and "giveaways" such as key chains, stress balls, and magnifiers to hand out in these rural areas to get the word out to sexual assault survivors about our services. The outreach materials will be specific to reach out to victims of the underserved communities including the African American, Latino, rural, and LGBT communities. In addition, we are requesting SASP funds to pay for two on -call cell phones necessary to our staff to answer hotline calls while they are on call each week. We will hold an awareness event for sexual violence survivors in April 2017. The amount requested is based on a previous awareness event held for sexual assault victims by Safehome.

## GENERAL GRANT CONDITIONS AND ASSURANCES

The applicant, for federal funds administered by DCJS, gives assurances and certifies with respect to the grant that it will comply with the following requirements:

1. The applicant assures that fund accounting, auditing, monitoring, and such evaluation procedures as may be necessary to keep such records as the Department of Criminal Justice Services shall prescribe shall be provided to assure fiscal control, proper management, and efficient disbursement of funds received under this grant.
2. **REPORTS:** Each applicant shall submit such reports as the DCJS shall reasonably request. Financial and progress reports shall be submitted to the DCJS on the **12th working day** following the close of each quarter unless otherwise informed.
3. **GRANT CLOSEOUT:** The last quarterly report of a project using federal funds must indicate any unpaid obligations, which exist at the expiration of the grant. The applicant has 90 days to liquidate any unpaid obligations and submit a final financial report.
4. **UNUSED FUNDS:** Any funds that have been requested, but unexpended at the end of the grant period will be refunded by check made payable to the **Treasurer, Commonwealth of Virginia**, and will accompany the final financial report when it is submitted to DCJS. (Most state agencies must use DPB form 27 and an IAT to return unused grant funds.) 5. **INSPECTION AND AUDIT:** The applicant agrees to comply with the organizational audit requirements of OMB Circular A-133, "Audits of State, Local Governments and Non-Profit Institutions." 8. **DISCRIMINATION PROHIBITED:** No person shall, on the grounds of race, religion, color, national origin, sex, or handicap be excluded from participation in, be denied the benefits or be otherwise subjected to discrimination under or denied employment in connection with, grants awarded pursuant to the Justice Assistance Act of 1984, and the implementing regulations 28 CFR Part 42, Subparts C, D, E, and G, or any project, program, activity, or subgrant supported or benefiting from the grant. 13. **CONFIDENTIALITY OF RESEARCH INFORMATION:** Research information identifiable to an individual, which was obtained through a project funded wholly or in part with DCJS grant funds, shall remain confidential and copies of such information shall be immune from legal process, and shall not, without the consent of the person furnishing such information, be admitted as evidence or used for any purpose in any action, suit, or other judicial or administrative proceeding (28 CFR Part 22).
14. **CRIMINAL INTELLIGENCE SYSTEMS OPERATING POLICIES:** The applicant agrees to be in compliance with all policies as expressed under the Code of Federal Regulations, 28 CFR 23, concerning the operation of criminal intelligence systems funded with DCJS funds.
15. **COPYRIGHT:** Except as otherwise provided in the conditions of the award, the author is free to arrange for copyright without approval when publication or similar materials are developed from work under a DCJS supported project. 16. **PATENTS:** If any discovery or invention arises or is developed in course of or as a result of work performed under this grant, the applicant shall refer the discovery or invention to DCJS. The applicant hereby agrees that determination of rights to inventions made under this grant shall be made by the DCJS or its duly authorized official representative, who shall have the sole and exclusive powers to determine whether or not and where patent application should be filed and to determine the disposition of all rights in such inventions, including title which may issue thereon. The determination of the DCJS or its duly authorized representative shall be accepted as final. In addition, the applicant hereby agrees and otherwise recognizes that the DCJS shall acquire at least an irrevocable non-exclusive royalty-free license to practice and have practiced throughout the world for governmental purposes any invention made in the course of or under this grant. The grant shall include provisions appropriate of effectuating the purpose of this condition in all contracts of employment, consultant's agreements, or contracts.
17. The applicant assures that funds made available under this grant will not be used to supplant state or local funds, but will be used to increase the amounts of such funds that would be, in the absence of these funds, made available for drug law enforcement activities.
18. Confidential expenditures for services, evidence and/or information must comply with the requirements stated in the Administrative Guide and Application Procedures Manual.
19. **BIO MEDICAL EXPERIMENTATION:** The applicant assures that no grant funds will be used for any bio-medical or behavior control experimentation on individuals or any research involving such experimentation.
20. The applicant agrees to complete a **Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion**, prior to finalizing any financial agreements pursuant to 28 CFR 67.510 (Code of Federal Regulations). This includes consultants under any award.


