I would like to request approval to offer scholarships for 13 VSTOP subrecipients to attend the annual *Facing Race: A National Conference* hosted by Race Forward. Race Forward is a national non-profit that engages in macro level work to organize and mobilize for a more equitable future. The annual event has hosted over 4,000 attendees across various sectors to provide tools, information and resources on racial equity. Attendees will be afforded the opportunity to build rapport with multiracial and inter-generational organizers and leaders to optimize their work across various disciplines. The virtual conference is being held from November 10-12, 2020.

The content delivered during this conference will prove to be vital to the work conducted by DCJS subrecipients and will promote culturally sensitive services and programs within the Commonwealth of Virginia. Workshops will be hosted on inclusive democracy, organizing and advocacy, and race identities, among other areas. Our subrecipients have endorsed that participation in this conference will, "Allow their staff to understand the intersectionality race has with other isms," "...ensure that service delivery is done with awareness and with an equitable lens," and "...allow prosecutors to be able to assess if actions demonstrated are racially biased or profiling."

The 13 scholarships are to be awarded to various VSTOP grant-funded staff ranging from victim advocates to prosecutors. Due to the conference being offered virtually, the only cost will be in the form of a registration fee for each individual. This will total \$3,900 (\$300/person). The regular conference rate is \$400 per person, but we have been invited to be included in the Action Alliance's group rate of 25% off.

Facing Race is known as the largest multiracial, multigenerational conference for racial justice advocates. In an effort to promote safety during the COVID-19 pandemic, Facing Race will be offered virtually. However, the host still promotes that attendees will receive an unprecedented

experience, which will enhance their knowledge and skills. DCJS declares that we are an antiracism agency that promotes equality, diversity and inclusion, and by allowing our subrecipients to attend this conference, we are further promoting this mission across the Commonwealth of Virginia.

The projected costs for attendance (per person) are outlined below:
