The VSTOP prosecutor is currently handling a sexual assault perpetrated by the victim's boyfriend. During this period, the prosecutor has advised on the investigation and arrest as well as seen the case through a preliminary hearing, at which the victim testified. The prosecutor spent significant time preparing the victim for the testimony and court appearance as well as preparing for the presentation of the case. The offender has a significant violent history which indicates he poses a dire threat to our community. Recently, a prior girlfriend of the offender has come forward to report similar assaults perpetrated by him against her. The prosecutor has spent time meeting and explaining the process to this second victim. As the perpetrator is a violent offender and serial offender, the handling on this case will have a significant impact on the safety of our community.
