EVIDENCE OF COMMUNITY COLLABORATION

- A) The V-STOP prosecutor attends monthly meetings of the Chesterfield Domestic Violence Task Force (DVTF) and bi-monthly meetings of the Chesterfield County Intimate Partner and Family Violence Fatality Review Team (FRT) and the Domestic Violence Criminal Justice Interagency Committee (CJI). The V-STOP prosecutor assists the DVTF with at least one presentation on domestic violence issues each year and assists in the training for Chesterfield County Police recruits on how to properly handle domestic violence incidents from investigation to trial. The V-STOP prosecutor assists the CJI by representing the Commonwealth's perspective on streamlining and improving interagency relations in the field of domestic violence.
- B) The V-STOP prosecutor is a member of the DVTF Training Committee and the Executive Committee. The V-STOP prosecutor is the representative for the Commonwealth's Attorney's Office on the FRT and the CJI.
- C) The DVTF meets every month. The DVTF Executive Committee meets bimonthly. The FRT and CJI meet bi-monthly.
- D) The DVTF focuses much of its efforts on community outreach and education. The DVTF has scheduled a training on Strangulation on October 25, 2018, with which the V-STOP prosecutor will be assisting. Furthermore, DVTF helps facilitate and organize Cooperative Agreements between local agencies. This is especially important, as some groups are specific to Chesterfield County, while others serve multiple counties and/or Richmond City.

- Provide service-specific expertise and technical assistance to the projects.
- Develop and provide specialized resources, awareness activities and training to assist collaborating agencies in enhancing services to older victims of domestic, family, and sexual violence.
- Develop specialized training curricula, resources and presentations on issues related to domestic, family and sexual violence in later life for criminal justice personnel and allied professionals.
- Offer training materials, resources and trainers to area law enforcement agencies to assist
