Subaward Project Description: **SASP funding helps fund our Bilingual Specialist, who is the staff member providing support to our Spanishspeaking clients. While this grant covers just over twenty-five percent of her time working with Hispanic/Latino clients, funding is vital to her providing services for 30 individuals experiencing some form of sexual assault crisis. Unfortunately, we anticipate those numbers staying the same for CY 2020. This is a very busy position providing individual and group support, referrals, education, court advocacy and hospital accompaniment for initial forensic exams. Her positive impact in the lives of this underserved population is a direct result of SASP funding. Additionally, we are looking to expand our services in response to a need in the community specifically for bilingual sexual assault support groups. PWC DSS already has eight families they can immediately refer to us for group support. ACTS Sexual Assault Services aims to provide as much support as a victim needs by providing gentle, trauma-informed guidance while they are on their healing journey. Additional funding would allow us to double the number of Hispanic/Latino clients served by offering these services. We are looking to hire four parttime Bilingual Sexual Assault/Abuse Group Facilitators (two for primary victims and two for secondary victims) to run weekly groups. SASP funding will directly support these services.**
