10:45am–12:00pm **Disciplined Too Young & Too Often: Understanding the School-To-Prison Pipeline** Nubia Peña, Training & Prevention Education Specialist, UCASA, North Salt Lake, UT

Across the country, school systems are shutting the doors of academic opportunity and funneling children into the juvenile and criminal justice systems by using overly harsh discipline practices and law enforcement to address student misbehavior. Anti-sexual violence advocates and community partners must be aware of current issues that increase a youth's vulnerability to perpetration in order to create innovative and relevant ways of engaging with targeted youth. This presentation will provide an overview of the pipeline and the various intersections of vulnerability that increase a child's risk of victimization. In addition, advocates will be encouraged to get involved in mitigating STPP issues to increase protective factors within schools by addressing policy change and reform.

1:30pm–4:30pm Paper Tigers: A Facilitated Discussion on Adverse Childhood Experiences

Jeanine Harper, Executive Director of SCAN Fred Orelove, TICN Trauma-Informed Schools Committee Co-Chair

More than two decades ago, two respected researchers, clinical physician Dr. Vincent Felitti and CDC epidemiologist Robert Anda, published the game-changing Adverse Childhood Experiences Study. It revealed a troubling but irrefutable phenomenon: the more traumatic experiences the respondents had as children (such as physical and emotional abuse and neglect), the more likely they were to develop health problems later in life—problems such as cancer, heart disease, and high blood pressure. To complicate matters, there was also a troubling correlation between adverse childhood experiences and prevalence of drug and alcohol abuse, unprotected sex, and poor diet. The results of the study painted a staggering portrait of the price our children are paying for growing up in unsafe environments, all the while adding fuel to the fire of some of society's greatest challenges. However, this very same study contains the seed of hope: all of the above-mentioned risk factors—behavioral as well as physiological—can be offset by the presence of one dependable and caring adult. That person doesn't need to be the mother or the father or even a close or distant relative. More often than not, that stable, caring adult is a teacher. It is here, at the crossroads of at-risk teens and trauma-informed care, that Paper Tigers takes root. Set within and around the campus of Lincoln Alternative High School in the rural community of Walla Walla, Washington, Paper Tigers asks the following questions: What does it mean to be a trauma-informed school? And how do you educate teens whose childhood experiences have left them with brains and bodies ill-suited to learn? Join us for a screening of the movie and facilitated discussion.

DCJS OVERVIEW



Virginia Department of Criminal Justice Services

The Virginia Department of Criminal Justice Services (DCJS), one of 11 agencies in the Secretariat of Public Safety and Homeland Security, occupies a unique place in state government because of its scope and responsibilities.

The Department directs programs and services to specific parts of the criminal justice system, for example crime victim assistance, or law enforcement; but DCJS is also charged with viewing the system as a whole in order to understand how changes in one component will affect the other so that plans and programs can be effectively coordinated.

DCJS is responsible for distributing federal and state funding to localities, state agencies, and nonprofit organizations for law enforcement, crime and delinquency prevention, juvenile justice and related services, victims services, corrections, and other areas; establishing and enforcing minimum training standards for criminal justice and private security personnel; and licensing and regulating the private security industry and other professions specified in the *Code* of Virginia. In connection with these activities, DCJS also provides training, technical assistance, and program development services to all segments of the criminal justice system; develops short- and longrange criminal justice plans; and conducts research and evaluations.

The agency has a broad constituent base that includes local and state criminal justice agencies and practitioners, non-profit agencies, and various private practitioners and businesses. DCJS also works with other local and state agencies, the federal government, and advocacy groups and associations.

The agency's budget consists of both state and federal funds, over 90% of which are distributed to localities, criminal justice agencies, and organizations through grants and other types of financial assistance.

The 29-member Criminal Justice Services Board is the agency's policy board, with representatives from all aspects of the criminal justice system, the private security industry, the public-at-large, and the General Assembly. Thirteen members serve by virtue of the offices they hold; 16 are appointed by the Governor.

The Board is the approving authority for the regulations that DCJS promulgates in accordance with the *Code of Virginia* and the Administrative Process Act. It also approves most of the grants the agency awards to localities, state agencies, and private non-profit organizations.

The DCJS website provides information on training and educational opportunities, grant funding, regulatory oversight processes, and the Department's programs. Recipients of grants from DCJS can use the site to access our online Grants Management Information System for specific grant award information at any time. The site also allows businesses and individuals to request information, register for trainings, and apply for various registrations, certifications, and licenses. The Virginia Center for School and Campus Safety provides training, resources, and technical assistance for law enforcement officers and school safety practitioners throughout Virginia.

Since the passage of legislation which mandated the creation of a threat assessment team in all Virginia public schools, threat assessment has been a hot, and oftentimes confusing, topic. To assist, the VCSCS published model policies and procedures and legal updates for threat assessment teams, and offers basic threat assessment and legal issues training. Additionally, to assist schools in explaining threat assessment and reporting to students, parents, and staff, VCSCS will be launching Virginia C.A.R.E.S. Virginia C.A.R.E.S. is a multi-pronged approach to engagement and awareness in schools that will include videos and resources on threat assessment. The campaign will work to build **C**aring, **A**wareness, **R**ecognition, **E**ngagement, and **S**upport in Virginia schools.
