Introduction of Members

Opening and Charge of Workgroup

Secretary Decker described to the members how they were chosen, and described their charge. Then other members of her staff and members of DCJS staff present were introduced.

Secretary Decker reminded the Workgroup that it is important that we move forward in the most productive way, and that includes keeping consistent with Freedom of Information Act (FOIA) requirements. We must post any document that members ask that we share. Members are asked not to "reply all" because to do so and start a discussion would entail having a public meeting and would be in violation of FOIA.

All members received recommendations forms. Every idea that members have that they want to make sure gets presented and discussed must be sent on the recommendation form to Laurel. DCJS will compile them and present the group with a document that will be used to guide the discussion on the recommendations. Most of this initial meeting today is intended to provide the foundation for the discussion of recommendations. At the Roundtable portion of today's meeting, we will start to look at areas for discussion. We need to focus in the meetings scheduled in January on issues that are high priority during the legislative session, namely items with budgetary needs and items requiring legislative change. There will be time in the meetings held between January 31 through June for us to bring in speakers on issues in which members express interest.

Status report on school and campus safety in Virginia

Donna Michaelis presented a report on behalf of the School Safety Center. She shared school and campus safety efforts done in the past decade by DCJS. She then entertained questions from the Workgroup.

DCJS Research Center presentation on school surveys and relevant reports

Sherri Johnson presented on behalf of the Research Center. She then entertained questions from the Workgroup.

Roundtable discussion

Before beginning the roundtable discussion, Secretary Decker identified the areas that the Workgroup is tasked with:

- Reviewing School Safety audits
- Identifying best practices
 - Can probably be lower priority until after Jan 31st
- The concepts of SROs, SSOs, arming teachers, arming school personnel; these will be wrapped up around internal security for schools; this discussion will be in two areas: K-12 and campus
- Identify needed improvements to the various pieces in legislation threat assessments, crisis management plans, audits (if involving legislation, these are high priority)
- Campus policies or procedures (if involving legislation, high priority)
- Examine current laws to identify gaps (since this deals with legislation, this area is high priority)
- Review recommendations in previous state and national reports and studies (DCJS will look at these and identify any recommendations still outstanding and to the extent that they require legislation they'll be high priority)
- Physical safety
- Perimeter protection issues
- Emergency notification issues
- Training, drills, prevention, school safety programs; school safety for personnel; security strategies
